MINISTER FOR SHIPPING INAUGURATES FERRY SERVICES

Shri Nitin Gadkari the Hon'ble Minister for Shipping, Road Transport & Highways and Water Resources, River Development and Ganga Rejuvenation inaugurated the Ferry Services from Baina, Vasco da Gama to Panjim on 20th March 2018 giving a further boost to Inland water ways tourism in the State of Goa. The Ferry service will be a great boon to the visiting tourists arriving at the Dabolim International airport and travelling to their hotels in the North Goa region.

Welcoming the Chief Guest, Shri Gadkariji and the other dignitaries present, Shri I. Jeyakumar IRTS Chairman, MPT said, 'The Ferry service from Baina, Vasco da Gama to Panjim will cut down on travel time from the airport and save a lot of time. Besides the Ferry service will give a good exposure to the visiting tourists. This is a new milestone in waterways travel and is a catalytic factor for tourism in Goa.'



The Hon'ble Minister Shri Nitin Gadkari addressing the gathering after inaugurating the Ferry Service said 'We have to commence water transport facilities and therefore the 7500 kms of inland waterways we have can be used for transport of goods and passenger traffic which will help increase the country's connectivity and significantly reduce the congestion on roads. The Government has identified 111 rivers in the country to develop Inland Waterways.

Highlighting the importance of developing cruise tourism in the country, the Minister stated that there is a lot of potential in the cruise tourism in India. During the next 5 years we are expecting that around 900 cruise liners will visit India. A luxury cruise ship between Mumbai and Goa will commence in the month of April 2018 where around 600 passengers could travel in luxury comfort, with several restaurants on board. Shri Gadkariji complimented the Chairman of the MPT Shri I. Jeyakumar for the initiatives he has taken for development in the port.

The Ferry Service which is a initiative of the Drishti Cruise & Service, facilitated by Mormugao Port Trust to boost tourism in the State is located at the Baina shore. The inaugural function held at the Baina beach was attended by Shri Shripad Naik Hon'ble Union Minister for AYUSH, Shri Narendra Sawaikar, Hon'ble MP Lok Sabha, Shri Vinay Tendulkar Hon'ble MP Rajya Sabha, Shri Francis D'Souza, Hon'ble Minister for Urban Development, Govt of Goa, Shri Mauvin Godinho Hon'ble Minister for Panchayat, Shri Milind Naik Hon'ble MLA Mormugao, Smt Alina Saldanha, Hon'ble MLA Cortalim, Shri Nilesh Cabral Hon'ble MLA Curchorem, Shri Rajiv Somany MD Drishti Cruise & Services, Trustees of the Board of MPT, senior executives of MPT, members of the Shipping fraternity, officials of the private port terminals at Mormugao, and citizens of Goa.

REPUBLIC DAY CELEBRATIONS AT MORMUGAO PORT

'Mormugao Port is one of the oldest port in the country and it has been serving the state and the nation for 130 years. The Port supports 6000 families directly and ten times more families of the trade indirectly. The well being of these families depends on the well being of the port. During this current financial year the port has undertaken a lot of infrastructure projects, and notable among them is the 4 lane highway, which will be completed soon and will ease the congestion on the roads in Vasco' said Shri I. Jeyakumar IRTS Chairman/MPT, while addressing an impressive gathering of Officers, staff, employees, parents, invitees, students and teachers at the 69th Republic Day celebrations at the Deepvihar School grounds, at Headland Sada. The Trustees of the Board, Dy. Chairman, Head of Departments were also present at the celebrations.





Shri Jeyakumar, earlier unfurled the National Flag, inspected the Ceremonial parade and took the salute at the Republic Day celebrations at the port. The March Past was held by the CISF Contingent of the Port, followed by the students of Deepvihar Primary, Secondary and Higher Secondary schools, and the Port Fire Brigade. The Chairman complimented the services of the Port Fire Brigade and Medical department in timely management and mitigation of the situation during the recent road accident of ammonia tanker. Officers and staff of the Marine Department, the Fire Brigade section and CISF personnel were honoured at the Republic Day function and presented with certificates and cash prizes for commendable service rendered to the Port. An impressive and colourful cultural pageantry was presented by the students of the educational institutions run by the Mormugao Port Trust Education Society.

The Chairman later along with the Dy. Chairman, HODs, visited the Mormugao Port Hospital accompanied by the First Lady Madam J. Jayalakshmi where they were welcomed by Dr. Nimish Pillai, Chief Medical Officer MPT Hospital, and the senior Medical Officers and staff. The Chairman and First Lady interacted with the inpatients at the port hospital inquiring about their health, well being and distributed fruits to all.

The cruise vessel having a LOA of 295.30 metres arrived under the command of Master Thomas Roth and was docked safely at the port Cruise Terminal under the able command of Capt Manoj Joshi Dy. Conservator, and Capt Shaji Ummer of Mormugao Port Trust.

MS ARCADIA ON MAIDEN VISIT TO MORMUGAO PORT

Luxury cruise liner MS ARCADIA of the P&O Cruises arrived at Mormugao Port from Colombo, Sri Lanka, on 27th March 2018, under the command of Capt. Ashley Cook, carrying 1919 high end guests and 863 crew members. The vessel with 285 metres LOA, was on its maiden visit to Mormugao Port. MPT PROVIDES SAFE SHELTER TO STRANDED FISHERMEN

Fishing trawlers which were left stranded off the coast with no possibility of returning back to their home due to low pressure area in Camorine region over the equatorial Indian Ocean and adjoining Camorine area were given safe shelter at Mormugao Port on 12th March 2018. An advisory was issued by the Coast Guard for fishing vessels as not to venture in to the affected areas.



Shri I. Jeyakumar, IRTS, Chairman, Mormugao Port Trust, took prompt action and instructed Capt. Manoj Joshi, Dy. Conservator/MPT to contact affected fishermen and help them in every possible manner. Several fishing trawlers with fishermen were given safe shelter at Mormugao Port and in a quick response, the Mormugao Port Trust welfare team provided the stranded fishermen with all relief material and food during their stay here in Port.

'ASPIRING ENTREPRENEURSHIP WORKSHOP' HELD AT MPT

'I Create' a non-profit organisation with a pan India presence engaged by the Mormugao Port Trust to impart training and technical knowhow to potential entrepreneurs from Vasco and Mormugao, conducted a 6 days 'Aspiring Entrepreneurship Workshop' in association with Mormugao Port Trust as part of their CSR activity. The program was inaugurated on 15th January 2018 at the hands of Shri G. P. Rai, Dy. Chairman/MPT, in the presence of Shri J. B. Dhawale Secretary/MPT and Shri Vinayaka Rao, FA&CAO/MPT, and Shri Nitin Bandekar - Director of NRB Group at the Port HRD Centre Headland Sada, and was conducted by 'I Create' Master Trainers including Nagendra Babu, Manish Gosalia and Mayur Arsekar.



27participants from Vasco and other places in Goa attended the workshop. This group enrolled based on the success of a previous AEW program conducted in Aug '17 wherein 21 individuals participated in the program and 9 individuals have started their own businesses. Participants included women self-help group members, homemakers, lawyers, IT professionals, retired Naval and MPT personnel, etc.

The participants appreciated the contents of the program and appreciated the in-depth learning on how to identify business opportunities, conduct market research, and understand the feasibility of the business idea and finally understanding the nuances of managing, marketing and running a business successfully. The participants also had an in-depth understanding of the financial requirements of managing a business including cash flow, Profit & Loss statements and break even analysis.

The program concluded with a Business Plan competition held on 20th Jan '18 and the businesses presented by the groups included Eco Friendly Bags Manufacturing, Edible Cutlery, Graphic Designer, Car Wash facility, etc.

RARE SATI STONE CARVING FOUND AT MORMUGAO

A rare Sati stone carving was found by Capt. Manoj Joshi, Dy. Conservator, Mormugao Port Trust in the compound of one unoccupied HOD Bungalow near the MPT Administrative building. The stone carving was lying covered under the bushes in the compound of the bungalow which is not in use. Capt. Joshi secured the stone carving and immediately contacted the Directorate of Archives, informing them of his precious find.

Shri Varad Sabnis, Asst. Superintending Archaeologist, Directorate of Archives & Archaeology, Panjim, later visited MPT and the stone carving which was found by Capt. Joshi was handed over to him. On examining the stone carving, Shri Varad Sabnis said that the sculpture which was found is around 300 to 400 years old and is a memorial of Sati or sacrifice done by a woman to the society. It is a significant find to help reconstruct the archeological past.

The stone carving has been taken over and shifted to the Directorate of Archives and Archeology and it will be on display for public viewing at the State Museum.

Unresolved Grievances Bothering You?

You may seek help of Directorate of Public Gnevances (DPG) in resolution of grievances relating to Ministries/Departments and Organisations under its purview. In last few years, nearly ninety percent of the gnevances taken up by the Directorate have been resolved favourably.

Please read carefully the conditions listed below before lodging your grievance:

- You should have exhausted the Departmental remedies for individual grievances.
- Your gnevance should not relate to service matter (other than payment of terminal benefits like gratury, GPF etc.). a case disposed of at the fevel of Minister of the concerned Department, commercial contract, a sub-judice case, a case where quasi-judicial procedures and appellate mechanisms are prescribed for decrision making. RTI matter, Religious matter.
- Suggestion of any sort will not be treated as grievance.
