मुरगांव पत्तन न्यास में हिंदी पखवाड़ा समारोह

मुरगांव पत्तन न्यास में दिनांक 14/09/2018 से 28/09/2018 तक हिंदी पखवाड़ा मनाया गया। "हिंदी दिवस" के उपलक्ष्य में अध्यक्ष (प्रभारी) श्री जी.पी.राय, सचिव (प्रभारी) श्री एस. पी. मोहन कुमार, अन्य वरिष्ठ अधिकारी और कर्मचारियों की उपस्थिति में हिंदी अधिकारी श्रीमती नीलम केंकरे द्वारा माननीय गृह मंत्री श्री राजनाथ सिंह का संदेश पढ़ा गया। कथित संदेश एमपीटी के सभी विभागों में भी पढ़ा गया।

इस अवधि के दौरान कर्मचारियों को उनके दैनिक कार्य में हिंदी का प्रयोग बढ़ाने हेतु प्रोत्साहित करने के उद्देश्य से विभिन्न कार्यक्रमों का आयोजन किया गया जिसमें हिंदी निबंध, टिप्पण व मसौदा और हिंदी वक्तृत्व "मन की बात" जैसी विभिन्न प्रतियोगिताएं शामिल थी। इसके अलावा मुरगांव तालुका स्थित माध्यमिक और उच्च माध्यमिक स्कूली छात्रों के लिए हिंदी निबंध प्रतियोगिताओं का भी आयोजन किया गया। टॉलिक, दक्षिण गोवा के तत्वावधान में वास्को स्थित सभी केंद्र सरकार के अधिकारियों और कर्मचारियों के लिए "सामान्य हिंदी प्रतियोगिता" आयोजित की गई। पत्तन के अधिकारियों और कर्मचारियों को अपना अधिकाधिक काम हिंदी में करने के लिए प्रेरित करने के लिए हिंदी कार्यशाला भी आयोजित की गई। दिनांक 06/10/2018 को हिंदी समापन समारोह संपन्न हुआ। इस अवसर पर भारतीय तट रक्षक के डीआईजी हिमांशु नौटियाल मुख्य अतिथि के रूप में उपस्थित थे। जन संबोधन करते हुए डीआईजी नौटियाल ने कहा कि हिंदी भारतीयों के बीच सामान्य वार्तालाप की एक भाषा है और यह राष्ट्रीय एकीकरण को बढ़ावा देती है। उन्होंने कहा कि हमारी राष्ट्रीय भाषा को उचित मान्यता देने की आवश्यकता है और इसलिए हमें हिंदी भाषा के विकास के लिए प्रयास करना चाहिए। उन्होंने यह भी कहा कि हमें सरकारी कामकाज में सरल और आसान हिंदी शब्दों का उपयोग करना चाहिए।

कार्यक्रम की शुरुआत में हिंदी अधिकारी श्रीमती नीलम केंकरे ने हिंदी पखवाड़े के दौरान आयोजित विभिन्न कार्यक्रमों के बारे में पावर प्वाइंट प्रेजेंटेशन दिया।

श्री एस. पी. मोहन कुमार, सचिव (प्रभारी) ने उपस्थितों का स्वागत करते हुए पत्तन कर्मचारियों और मुरगांव तालुका के विभिन्न स्कूली छात्रों की विविध हिंदी प्रतियोगिताओं में सहभागिता की सराहना की।

पत्तन में स्वतंत्रता दिवस समारोह

दीपविहार प्राइमरी स्कूल ग्राउण्ड पर आयोजित भव्य स्वतंत्रता दिवस समारोह में राष्ट्रीय ध्वज फहराने के पश्चात जनसमुदाय को संबोधित करते हुए श्री आई. जेयकुमार, आईआरटीएस/ अध्यक्ष,एमपीटी ने कहा कि 15 अगस्त 1947 भारत के पुनर्जन्म का दिवस है जो स्वतंत्रता दिवस के रूप में मनाया जाता है, जिस दिन ब्रिटिश शासन से भारत को आजादी मिली। इसलिए यह हमारे देश के इतिहास में सबसे महत्वपूर्ण दिनों में से एक है जिसे बड़े उत्साह के साथ मनाया जाता है। भारत के 72 वें स्वतंत्रता दिवस में पदार्पण करते हुए हमें उन महान नेताओं और स्वतंत्रता सेनानियों के महान त्याग को याद रखना होगा जिन्होंने भारत देश की स्वतंत्रता के लिए अपना बलिदान दिया। इस अवसर पर पत्तन के न्यासी, ट्रेड यूनियनों के प्रतिनिधि, उपाध्यक्ष, विभागाध्यक्ष, पत्तन प्रयोक्ता, पत्तन अधिकारी और कर्मचारी उपस्थित थे।

अपने संबोधन में श्री आई. जेयकुमार, आईआरटीएस/ अध्यक्ष,एमपीटी ने यह भी कहा कि मुरगांव पत्तन देश के सबसे पुराने पत्तनों में से एक है। यह पत्तन 130 से अधिक वर्षों से राज्य और राष्ट्र की सेवा कर रहा है। पत्तन में क्रूज यातायात को परिलक्षित करते हुए अध्यक्ष ने कहा कि क्रूज पर्यटन पत्तन का केन्द्र बिन्दु है। अंतर्राष्ट्रीय क्रूज क्षेत्र में कई निवेश योजनाएं बनाई गई हैं। वर्ष 2025 तक पत्तन ने क्रूज सीजन के दौरान 100 से अधिक क्रूज जहाजों की संभलाई का लक्ष्य रखा है। उन्होंने उम्मीद जताई कि आने वाले सालों में पत्तन अपने पूर्वोत्कर्ष को वापस पाएगा।

SWACHHTA HI SEVA CAMPAIGN HELD SUCCESSFULLY

Mormugao Port Trust observed Swachhta Hi Seva Abhiyan from 15th September to 2nd October 2018. Various events were organized to bring about awareness on the importance of cleanliness and protection of the environment. Capt. Manoj Joshi, Dy. Conservator, inaugurated the 'Swachhta Hi Seva Campaign 2018' on 15th Sept 2018, in the presence of the Heads of Departments, Officers and staff. The Cleanliness Pledge was administered to all present in Hindi by Shri S.K.S. Hegde, CME (i/c) and in English by Smt. L.A. Mathew, Chief Engineer. Shri G.R. The luxury cruise liner season 2018-2019 began on a high note at the Mormugao Port with the arrival of the first cruise liner MV VIKING ORION at the cruise berth terminal on 10th Sept 2018 with 884 guests from Mumbai Port.

Shri G. P. Rai, Chairman (i/c) MPT visited the cruise ship at the cruise berth terminal along with the Heads of Department, Dy. Commandant CISF, and extended a warm welcome to the Master Capt. Rune Lockling. Shri G. P. Rai Chairman (i/c) welcoming the Master, Officers, and crew on board the cruise liner impressed upon the Master that the State of Goa is a much favoured tourist destination for cruise passengers on the west coast of India due to its rich cultural heritage, pristine beaches, heritage monuments and world famous cuisine which blends the East and West cultures. The Chairman (i/c) also updated the Master about the cruise ships that are scheduled to arrive at Mormugao during the current season.

The Joint Secretary was impressed with the visit to Mormugao Port and evinced keen interest in the new Satellite Port project. He expressed his happiness on the measures taken by MPT on the Green Port initiative and pollution control measures implemented in the port and its environs. He also highlighted the Ministry's focus on implementing the Sagarmala Projects in the country and the availability of grants to the Port sector through the Sagarmala Development Corporation. The meet ended with the Joint Secretary complimenting the Chairman and Officers of the Port.



CONSUL GENERAL JAPAN VISITS MPT

'Back home in Japan we have learnt about Goa and that the Portuguese ruled over here in our history books. But, there is a need to know and learn more about Goa with respect to its tourism potential in the Far East. Our two countries enjoy friendly relations and we have good trade relations too. We need to take the trade relations between our countries forward' said His Excellency Mr. Ryoji Noda, Consul General of Japan in India during his brief visit to the Mormugao Port Trust, on 6th September 2018.

His Excellency Mr. Ryoji Noda, Consul General was received by Shri G. P. Rai Chairman (i/c), MPT at their main administrative building. The Chairman (i/c) along with the Heads of Departments had wide ranging talks with the visiting dignitary in the Board Room.

Shri Vipin R Menoth, Traffic Manager MPT, gave a brief on the Mormugao Port, its history, location, infrastructure facilities available to the trade and the cargo profile. A short documentary on the Mormugao Port was also presented to the visiting dignitary.

- Your grievance should not relate to service matter (other than payment of terminal benefits like gratuity, GPF etc.), a case disposed of at the level of Minister of the concerned Department, commercial contract, a sub-judice case, a case where quasi-judicial procedures and appellate mechanisms are prescribed for decision making, RTI matter, Religious matter.
- Suggestion of any sort will not be treated as grievance.
