TOLIC MEETING HELD AT MORMUGAO PORT TRUST

The first meeting of Town Official Language Implementation Committee (TOLIC), South Goa for the year 2019-2020 was held on 8th May 2019 at 3:00 p.m. at MPT Guest House, Headland Sada under the aegis of Mormugao Port Trust. The meeting was presided over by Dr. E. Ramesh Kumar, IAS, Chairman, TOLIC, South Goa and Chairman, Mormugao Port Trust. The function was also graced by Dr. Sunita Yadav, Dy. Director (Implementation), Department of Official Language, Ministry of Home Affairs, Govt. of India, DIG Himanshu Nautiyal, District Commander, District Headquarters Coast Guard no. 11 (Goa) and Shri Gagan Malik, Director, Airport Authority of India. Heads and representatives of various Central Govt. Offices, Banks, and Public Sector Undertakings located in and around Vasco also attended the meeting. In his welcome address, Capt Manoj Joshi, Chairman, TOLIC Sub-Committee and Deputy Conservator, Mormugao Port Trust while stressing the importance of Hindi language expressed that Hindi is a rich and varied language and there should be no hesitation in its usage. The fourth issue of Hindi Magazine of TOLIC, South Goa entitled “Vasco Rashmi” and the third issue of Annual Hindi Magazine of Mormugao Port Trust entitled “Goem Port Darpan” were released on this occasion at the hands of Dr. E. Ramesh Kumar, IAS. The prizes to the winners of various competitions organised by some Member Offices under the auspices of TOLIC, South Goa were also distributed at the hands of dignitaries present. In his presidential address, Dr. E. Ramesh Kumar, IAS, expressed his pleasure on account of special activities organised by the Member Organisations and also congratulated the winners of various competitions. Speaking on this occasion, Dr. E. Ramesh Kumar, IAS quoted that this Committee serves as a major instrument in expediting the implementation of Hindi as official language in Government sector and emphasised that Heads of the Offices should invariably attend the said meetings. 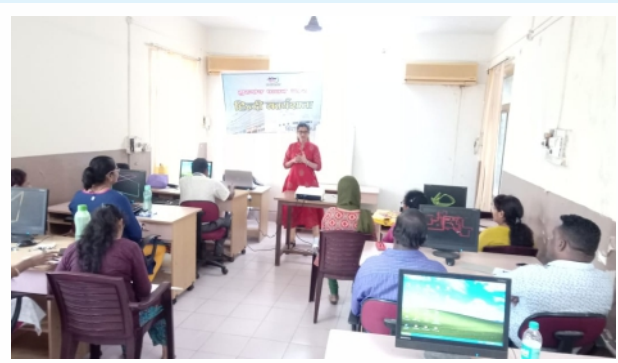

SENSITISATION WORKSHOP ON CRUISE TOURISM AT MPT



“Traditionally ports in India are segments for trade and modes of transport for cargoes, but world over many countries are thriving on tourism as an important ingredient of economy. The very thought of tourism is changing, the simple reason being that better connectivity has brought an overall change and we are able to reach places. The important word in cruise tourism is the experience one would accrue from that. Goa in India is a citadel for tourism in India and it has its own uniqueness about its natural beauty” said Dr. E. Ramesh Kumar, IAS Chairman MPT. He was addressing the dignitaries and delegates of the 'Sensitisation Workshop on Cruise Tourism' held at Mormugao Port Trust jointly under the auspices of the Ministry of Tourism, Government of India, and MPT. Dr. E. Ramesh Kumar further said “There is a tremendous increase in the cruise tourism calls at Mormugao Port in the last five years. We have touched around 102 cruise calls in the just ended financial year, and the

figures will double in the coming year. The cruise passenger arrivals were around 70,000 to 80,000 during the just concluded season. I am confident the figures will touch to around 1.5 lakhs in the current year. I can assure you that with the support of the Ministry of Tourism and the enthusiasm of the Ministry of Shipping, we will set up a state-of-the-art cruise terminal”. Smt. Neela Lad, Regional Director (Western Region) India Tourism, gave a presentation on 'Importance and benefits of cruise tourism'. She laid emphasis on the growth and future of international cruise tourism. She said 'Cruise tourism helps the state to strengthen its economy, and is an employable opportunity for manpower in different segments. Cruise tourism needs five main services to work in tandem with each other Viz., the Port, Port authorities, Customs, Immigration and the Security. If these five services work together cruise tourism can be at its best.” The workshop received overwhelming response from important stakeholders from the Cruise Tourism Industry in the state of Goa. Central Government Agencies like the Customs & Central Excise, Bureau of Immigration, CISF, and the senior Officers of the Goa Tourism Development Corporation, Goa Police, Shri Agnelo Fernandes Additional Collector, (South) Government of Goa, Travel Agencies, and Shipping Agents were present at the workshop. Shri Vipin R. Menoth, Traffic Manager MPT, in his concluding remarks while thanking all for their overwhelming participation assured all the delegates and stakeholders present at the workshop that the Port will spare no efforts to provide all the requirements as well as upgrade the port facilities to meet the needs of cruise tourism in the State during the ensuing cruise season so that the industry flourishes in the state of Goa.

INTERNATIONAL YOGA DAY CELEBRATED AT MPT

The International Yoga Day (21st June) was celebrated at the Officers' Club of Mormugao Port Trust. The function was organized, by the Medical department of MPT under the guidance of Dr. Nimish Pillai, the Chief Medical Officer. The function was graced by the presence of Dr. E. LARGEST CRUISE LINER VISITS MORMUGAO PORT

4th February 2019, was a glorious day for the Mormugao Port Trust when it hosted one of the largest ocean cruise liners MS QUEEN MARY 2 on its maiden visit to Goa with 2491 guests and 1259 crew on board. The cruise liner which arrived from Muscat, Oman was commandeered by Capt. Christopher Wells. Having an LOA of 345.03 metres and draft of 10.3 metres, this is the largest cruise liner to ever visit Mormugao Port Trust. Goa is the only Port where the vessel called during its voyage to India. Being the maiden visit of the luxury cruise liner, Shri G.P. Rai, Dy. Chairman of MPT along with Shri Vipin R. Menoth, Traffic Manager, Capt. Manoj Joshi, Dy. Conservator, Shri Jerome Clement Sr. Dy. Traffic Manager, Capt Arun Kumar, Harbour Master, Shri Mohan



Kumar Secretary (i/c), and other senior officers of the port visited Capt. Christopher Wells on board the cruise liner and extended a warm welcome to the state. The Traffic Manager Shri Vipin R. Menoth briefed the Captain and other officers on the cultural and historical importance of the state of Goa on the West Coast of India and its importance and status on the world tourism circuit. Shri G. P. Rai Dy. Chairman and Capt. Christopher Wells later exchanged commemorative plaques as a token of goodwill on the liner's maiden visit to Mormugao port.

MV COSTA VENEZIA ON MAIDEN VISIT TO MORMUGAO

Mormugao Port played host to luxury cruise liner M.V. COSTA VENEZIA of the Costa Cruises on her maiden call from Khor Al Fakan Port in Sharjah on 3rd April 2019. The cruise ship is specially designed and built for the China market. The cruise liner arrived with 2497 foreign guests and 1241 crew members to the state. Shri Vipin R. Menoth Traffic Manager, MPT, along with senior Officers of the port Shri Vijaya Dat Kagita, IOFS, CVO MPT, Capt, Arun Kumar, Harbour Master, Heads of department and other executives visited the cruise ship. Tihomir Muzic said 'This is our first visit to an Indian port and India will be our future cruise market and I am happy and pleased to be here.

Unresolved Grievances Bothering You?

You may seek help of Directorate of Public Grievances (DPG) in resolution of grievances relating to Ministries/Departments and Organisations under its purview. In last few years, nearly ninety percent of the grievances taken up by the Directorate have been resolved favourably.

Please read carefully the conditions listed below before lodging your grievance:

- You should have exhausted the Departmental remedies for individual grievances.
- Your grievance should not relate to service matter (other than payment of terminal benefits like gratuity, GPF etc.), a case disposed of at the level of Minister of the concerned Department, commercial contract, a sub-judice case, a case where quasi-judicial procedures and appellate mechanisms are prescribed for decision making, RTI matter, Religious matter.
- Suggestion of any sort will not be treated as grievance.

अपनी शिकायत दर्ज कराने से पहले कृपया नीचे दी गई शर्तों को ध्यानपूर्वक पढ़ें :-

- आपने अपनी शिकायतों को सम्बंधित विभाग के समक्ष समाधान हेतु प्रस्तुत कर लिया हो।
- आपकी शिकायत सेवा मामले (ग्रेजुएट, जीपीएफ इत्यादि जैसे सेवागत कृत्यात्मों के घुसटान के अलावा), संबंधित विभाग के मंत्री के स्तर पर निपटारा गए मामले, कनिष्ठिक अनुबंध, न्यायाधीन मामले, ऐसे मामले जहाँ निर्णय लेने के लिए अर्द्धन्यायिक प्रक्रिया और अपील प्रक्रिया निर्धारित की गई है, आरटीआई मामले, वार्षिक मामले से संबंधित न हो।
