REPUBLIC DAY CELEBRATIONS AT MPT ON (26-01-2021)

The 72nd Republic Day of India was celebrated at the Mormugao Port Trust on 26th January, 2021 at the premises of Main Administrative Building, Headland, Sada. At the outset, the Chief Guest of the function, Dr. E. Ramesh Kumar, IAS Chairman, MPT unfurled the National Flag and took the salute followed by the national anthem in the presence of Dy. Commandant CISF, Board of Trustees, Heads of Departments, Port Officers, representatives of the Trade Unions, teachers of the Port managed schools and invitees by strictly maintaining social distancing norms and wearing of mask.

A THREE DAY YOGA TRAINING PROGRAMMES ORGANISED BY TRAINING CELL OF MPT

MARITIME INDIA SUMMIT

Ministry of Ports, Shipping and Waterways organised a grand virtual “Maritime India Summit 2021”, in its second edition, to showcase and promote both domestic and international investment in the Indian Ports and Maritime sector from 2nd to 4th March, 2021.

The main event of the “Maritime India Summit 2021” was on the 2nd March, 2021 with inaugural by the Hon'ble Prime Minister of India till its conclusion on 4th March, 2021. It included speeches from Maritime, Logistic & Financial Experts, both International and Domestic, release of Movie, Brochures, Video and Power Point presentations, signing of MOUs, Pavilion for Exhibitors, B2B and G2B meetings, and Q&A sessions.



Hon'ble Prime Minister Shri Narendra Modi released the 'Maritime India Vision 2030', followed by the launch of Sagarmala – Sagartat Samridhi Yojana; Arth Ganga Programme; National Logistic Portal (Marine) Project.

The event was attended by various stakeholders in the maritime sectors such as Policy Planners, Senior Government Officials, Domestic and International Investors, Sector Experts, Shipping Line Owners, Representatives of Major Ports from across the world as well as the Governments of Maritime States in India. The last day of the mega event, 4th March 2021 was designated as Chabahar Day to focus exclusively on the development of Chabahar as a maritime hub for trade with Afghanistan and The International North South Transport Corridor Countries.

Visit to Old Age Home

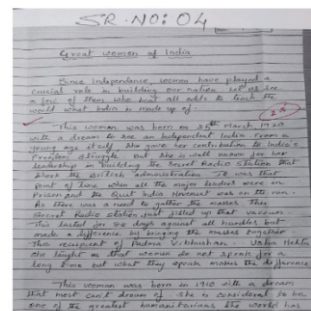
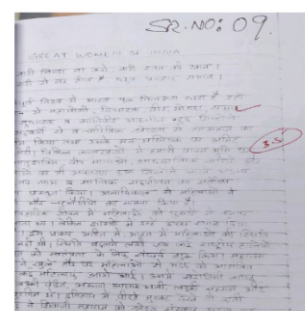
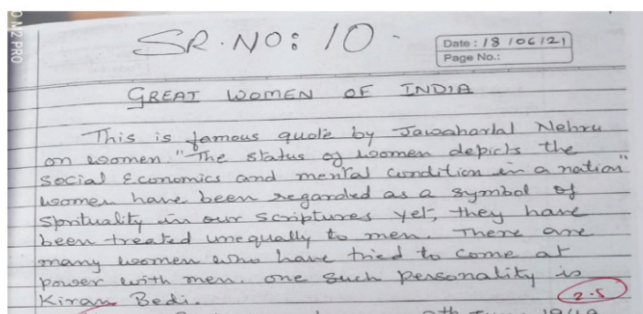

Unresolved Grievances Bothing You?

You may seek help of Directorate of Public Grievances (DPG) in resolution of grievances relating to Ministries/Departments and Organisations under its purview. In last few years, nearly ninety percent of the grievances taken up by the Directorate have been resolved favourably.

Please read carefully the conditions listed below before lodging your grievance:

- You should have exhausted the Departmental remedies for individual grievances.
- Your grievance should not relate to service matter (other than payment of terminal benefits like gratuity, GPF etc.), a case disposed of at the level of Minister of the concerned Department, commercial contract, a sub-judice case, a case where quasi-judicial procedures and appellate mechanisms are prescribed for decision making, RTI matter, Religious matter.
- Suggestion of any sort will not be treated as grievance.
